## **Superintendent's Report**

<u>Topic One:</u> Ms. Gormley talked about summer cleaning and bus issues, noting that Transportation Director Jake Smith has worked hard all summer. They have added a bus but they are still resolving issues. Asked for patience. Mr. Zullas asked if this was the bus company's fault and Ms. Gormley said nobody was to blame. Ms. Gormley talked about this being Janet Sheehan's first meeting as Assistant Superintendent for Curriculum and Human Resources. Ms. Gormley talked about Holly Concannon's appointment as Principal of Collicot. She noted that Special Services Administrative Assistant Janet Potts last day was today and her retirement party was last night.

Ms. Gormley said the district hired 29 teachers for the start of school, but they are not 29 new positions. Some of these appointments were filling retirements, resignations, etc. She talked about the creation of the technology administrator and the recent appointment of Dr. Angela Burke. She also discussed the creation of the Parent Liaison position and said they are still interviewing for data specialist position. Ms. Gormley also noted that an, additional heath position at Pierce was approved over the summer. Ms. Sheehan discussed the mentoring program for new teachers and the back-to-school schedule. Ms. Gormley noted hat they added a new kindergarten classroom at Cunningham and new first grade at Glover Elementary School. Ms. Gormley said she will bring Jackie Morgan in to discuss the new regulation regarding what type of food can be served under the new guidelines. Student Rep Matt McCarthy described how the breakfast cart works to provide breakfast in the morning for students.
