Call to Order

The Chair called the March 29, 2017 meeting of the School Committee to order at 7:02pm.

Citizens Speak: Bernadette Butler, Elementary Science Coordinator, came to speak about Science for Scientists and their upcoming fundraiser, Chip in Fore Science.

Next, Denise Queally came to speak about the Milton Foundation for Education and their upcoming fundraiser, Celebration for Education. School Committee members thanked Ms. Queally for her work on behalf with the MFE.

Next, Dominique Thomas came to speak about Project 351 and her Spring Service project for Cradles to Crayons. She is the Milton Ambassador to Project 351. Bins are out in every one of the Milton Public Schools. She thanked Dr. Spaulding and those who have helped her along the way.

Approve Agenda

The committee approved the agenda. The chair removed Item 4c and add Item 7e, under Policy Subcommittee. Ms. Bagley Jones moved to add Item 5d to discuss support of immigrant and transgendered students.

Superintendent's Report

<u>Topic One:</u> The Boys Indoor Track Coach Chuck Ajemien came to the table, along with MHS sophomore Smith Charles. Coach Ajemien talked about Smith's achievements. Ms. Varela commended Smith and said she was happy to hear that Mr. Charles is "a better person than he is an athlete."

Next, Tom Shaw spoke on behalf of the Girls Indoor Track Team. He talked about work ethic, confidence, and their recent success at Nationals, where two girls' teams earned All American status. Ms. Varela talked about the pride they've brought to the town.

Ms. Gormley talked about how the town is proud of this team and thanked Tom Shaw for his successful season.

<u>Topic Two:</u> Pierce Middle School Grants (Attachments) -- Principal Karen Spaulding and Science Coordinator Christie Chiappetta came to speak about the FUSE grant for the Greater Boston Area, the Massachusetts Clean Energy Center (to support a Clean Energy Activity Day); and Safe and Supportive Schools Grant.

<u>Topic Three:</u> Milton High School music department trip to NYC, Final Approval. The chair moved to approve the upcoming spring field trip.

<u>Topic Three:</u> Revised 2017-18 School Year Calendar (Attachment) (Vote)

Dr. Pavlicek explained that there were two changes. They moved the half day on October 11 to October 18th. The teacher conference/PD Day on November 8th will be moved to November 9th, with the approval of the MTA. The final one was the PD day in January. It was originally

Jan 10th, but had to be moved one day up. The original calendar resulted in three consecutive four-day weeks. This was moved to January 31st. Overall, three PD days were moved. Mr. Walker moved approval of the revised calendar.

<u>Happenings</u>: Ms. Gormley announced that Program of Studies Night was tonight. Tomorrow night will be BoomWriters celebration. Also, asked if Dr. Pavlicek and Ms. Sheehan could give a summary of First Grade English/French choice selection and K numbers.

Dr. Pavlicek said that First Grade Course Selection has been made and there are 189 rising first graders chose English/STEM and 157 for French Immersion. The breakdown was 55% English, 45% French. Of the 16 Kindergarten classes, 10 will be English first graders, 6 in French. Lotteries were held at two schools. Twelve students did not get French who asked for it. Ms. Bagley Jones asked about class sizes and was told that French Immersion classes are capped at 26; English cap is 22.

Ms. Sheehan talked about the kindergarten process. Families of incoming K students will be sent school assignment and screening appointment by April 20th. Currently, there are 208 fully registered K students and 27 more in the works. Our schools were built for 14 K classrooms, we've had 15 for 6 years and this current year, 16 classrooms. Our numbers today require 15 classrooms, but we are anticipating at last 16 classes. We remind families that they will be notified in early May, date and time for screening appointment. Ms. Bagley Jones asked do we have enough space? Where would we put them if we need more classrooms? Mr. Walker said we can accommodate 16. At 17, we would have to take other rooms.

Ms. Gormley noted that the school just finished this years's very popular and successful musical concerts. This month, they are celebrating the Passport to the Arts Program. Ms. Gormley also noted that on Saturday morning, she received an email from Sgt. Jack Richman of the Milton PD regarding a parking situation near the Pierce Middle School. On that day, we had rented out the Pierce to the Commonwealth of Massachusetts to administer the Civil Service exam. Ms. Gormley apologized for the excessive amount of cars in the residential neighborhoods around the Pierce Middle School and outlined her plan to prevent such parking issues in the future.

Chairman's Report

Topic One: FY18 Budget Update

<u>Topic Two:</u> Revised FY18 Non-Contingent Reductions (Attachment) (Vote)

The chair chose to take Topic One and Topic Two together. He has seen one draft of the warrant, and said the action they need to take are included in the warrant. He said the budget amount for Blue Hills Regional was lower than anticipated, so \$73,000 will be coming back to the schools. Due to this, it was agreed the Incision Specialist be removed from the reduction list. The chair moved to accept this revised cut reduction list.

Discussion: Ms. Bagley Jones said she's upset about these cuts. Eliminating band, strings and

ACE is discouraging. Mr. Walker agreed.

Topic Three: Ms. Bagley Jones noted that after the President Trump's executive order regarding immigration and transgender students, some school districts have passed resolutions of support for those students. DESE Commissioner Mitchell Chester came out against these two policies. She would like to draft a letter of support from the Milton School Committee and send to legal counsel, and ultimately approve, then sign it. Mr. Walker has a slightly different recommendation. He suggested that the School Committee gather those letters from other School Committees and we'll read them and discuss on April 12th. The Superintendent has some guidance from our legal counsel about this issue. Ms. Bagley Jones said she's already collected some letters. Ms. Varela aid she's great that we take a step forward.

<u>Topic Three:</u> Powers & Sullivan End-of-Year Report, June 30, 2016 (Attachment) The chair asked the members of the School Committee to review this document.

The chair made an omnibus motion to approve three warrants.

<u>Topic Four:</u> Special Education Software (Attachment) (Vote) This new system has the ability to check for errors, etc. This software is necessary to move the SPED department data into the 21st century. The cost is to come out of Medicare fund.

Discussion: Ms. Eberhardt said this is a technology tool. There is a continuing expense for this software, which is \$16,293 in the second year. Dr. Donahue asked, will this fix the problem, or is this a step towards fixing the problem? Ms. Gormley said this is not the perfect answer, but Ms. Grandeau did a great deal of research on this topic. KBJj asked if this will make it easier for teachers to access IEPs and was told that yes, it would.
