Milton SEPAC Board Election Information Sheet

2018-2019 School Year

Board members are elected by the general membership and hold office for one year, except for the Chairs who serve terms of two years. The SEPAC Executive Board includes two Chairpersons, the Secretary, and the Treasurer. Additional Board Members include up to two representatives for each school, including the preschool and students in out-of-district programs.

Per the bylaws, general membership is open to any parent or guardian of a student who receives special education services or 504 accommodations, students, age 14 or older, receiving special education or Section 504 accommodations, and any other interested party. All general members are invited to submit nominations. Voting membership, required to vote in elections or other business that comes before the SEPAC, is open to parents or guardians of children receiving special education services or 504 accommodations.

The mission of the Milton SEPAC is to work for the understanding, acceptance, inclusion, support, and respect for all children with special needs in the community. To that end, Milton SEPAC will work toward the best education for all students within the Milton Public Schools. Milton SEPAC shall:

- * Serve as a network for parents of children with special needs and others to share information and resources relative to special education and disabilities.
 - * Meet regularly with School District to participate in the planning, development, and evaluation of the District's special education programs and policies and with parent and teacher training needs;
 - * Collaborate with the District on identifying and improving educational outcomes for students with disabilities.
 - * Advise, participate and encourage the District to fulfill the requirements and duties outlined in Federal and State Education Law in matters of the education, inclusion, and safety of students with disabilities.
 - * Fulfill the SEPAC requirements and duties set forth in Massachusetts special education laws and regulations: M.G.L. Chapter 71b and 603 CMR 28:03 (1)(a)(IV) & 28.07(4).
 - * Promote an educational environment wherein all students have equal access to and meaningful participation in academic and nonacademic programs and opportunities.
- Promote communication between SEPAC members, local, State and National organizations, councils and groups and programs within the community to encourage understanding, acceptance, and inclusion.
