- Had issues with three girls in her class around her daughter's hair being different than everyone else's. Met with Superintendent Gormley at the time and we were able to overcome the situation.
- Needs to be more culturally competency
- Joined committees to be involved and wanted to help with the change
- Also encountered situations where her daughter heard the "n" word used over and over again
- Went to Dr. Spaulding and inform her that it was an issue and that it needed to be addressed
- Told a letter would be put out all parents about racism and there was never a response
- There have been boys who have confronted her daughter over and over
- PMS sat back and did nothing and said there was a training on the "n" word
- Shutting down black and brown children, their voices needed to be heard
- For 2 years her daughter has reported the bullying, it has become the silent killer of black children not to be heard
- Profiling black children which leads suspension, white students are doing the same but not receiving the same discipline
- Complaints about teachers and still no response to this day
- Killing the black children's spirit
- Need to have better answers for our children
- Have not done enough, there has been hurt, need to stop silence the black voices

Patricia Guglietta

- 2 children that began at PMS, adopted her children who are Haitian and have the unique perspective of a white woman
- Work primary with immigrant families in Chelsea, MA
- Physician of the MPS
- What can be done going forward?
- Students were doing a project, there was a hierarchy of a chart where the teachers were up top and the children at the bottom and were called slaves. Brought to the attention to Mr. Fitzgerald who stated that he was not offended by the terminology.
- Son was targeted for being black and disciplined
- Sits with only the black/brown kids at lunch, tend to be the tables that always get in trouble
- Was just happy at Tucker, not happy with Pierce
- This is a stepping stone, School and teachers need to do a better job. This culture is heartbreaking

5. Citizen Speak Topic Response - School Committee

Chair Varela made a statement that on behalf of The School Committee; we do hear you and believe you. Chair Varela stated that this was a very powerful evening and also very disheartening. She agreed that a lot of work needs to be done. Stated that Milton is not a perfect school system and hearing the stories about Pierce were concerning. Chair Varela thanked the parents for speaking so honestly. Statements were powerful andemotional. She apologized to the parents for their experiences with the MPS. Chair Varela commented that all the testimonies underscore the need for the Milton Public School to accelerate and deepen work that needs to be done. Milton Public Schools needs to be a more welcoming, inclusive and equitable school system. Chair Varela stated it is time to look forward and focus on some of the initiatives and what needs to be done for the immediate future and beyond. She thanked the Anti-Racism Coalition and stated that the School Committee is ready to make the investment to make the change. The School Committee has a critical role to play in planning, policies and finances. Chair Varela stated she is ready to stand and lead with conviction.

Ms. Rosmarin thanked all the speakers for sharing their experiences. Ms. Rosmarin stated that Milton has become more diverse over the past 32 years. Commented that all her children were all raised here and attended the Tucker School. She stated it was heartbreaking to hear about parents considering having their children go elsewhere for middle school. Ms. Rosmarin also stated that she heard the parents, believed the stories and thanked the parents again for speaking.

Ms. Eberhardt commented that she was in a bit of shock, stated to all the families that the School Committee hears, sees you and wants to work harder together. Ms. Eberhardt commented that she has worked with Winston Daley and Beverly Ross Denny on Committees. She stated that the School Committee is not the best forum to communicate with the community and would welcome more conversations with parents. She stated that the School Committee and the commitment to the work against racism. Thanked parents again for coming forward and speaking. Ms. Eberhardt encouraged parents to run for the School Committee and welcomes new members.

Ms. White thanked all the parents for speaking, understands it takes a lot of courage to speak about such personal and painful experiences. She stated that she appreciated their

honesty and the willingness to share. Ms. White commented that the School Committee is listening to the families and the children. She stated that the School Committee needs the help of the families, their passion and hopes that the families do not give up on the Milton school system.

Dr. Donahue stated he felt grief listening to all the experiences from the families and the reactions with how the families' experiences were met. Dr. Donahue stated it took too long to get here and apologized for everything.
