Dr. Alyssa Perkins - 118 Wolcott Road

- Need to make our schools fun in Milton
- Know more about Covid
- School playgrounds are safe, open all over the state and town
- Yet our children are still deprived from playtime
- Asking to reevaluate the recess play policies for children
- Shared materials/library and renting books is not an option for the children
- With good hand washing and sanitizing this could be option for the children asking to lessen restrictions especially around library books

Maryann Kinsella - Artwell Street

- Congratulated Superintendent Jette on his new position
- Explained to School Committee that she has had to leave her job permanently because of her son struggling with the Hybrid Model
- Feels like she cannot be the only parent in this situation

- Spoke out at listening sessions, need to have a rigorous hiring process

- Thanked the Superintendent for implementing the new improved Hybrid Model
- At the last School Committee meeting it was mentioned that Milton would not return to school fully this year
- As a parent and with other members of the school community strongly disagree with this perspective
- Every child should be back to school this year

 - o left the Inclusion Task Force in 2017 because of a lack clear directives and task
 - informed Superintendent Gormley and members of the School Committee that she was concerned
 - She was told she needed to be patient and that she didn't understand how the process worked
- Wondering if this current School Committee was aware of this task force
- Like to request that the quality review be transparent with the timeline, and how much is being paid so there is accountability

c. <u>District Updates - Superintendent Jette</u>

Congratulations to MHS Senior Jazz Ensemble member Philip Phan for being selected to the 2021 All Eastern Division Jazz Ensemble. Eastern Division is composed of the finest high school musicians from Connecticut, Delaware, Massachusetts, Maryland, Maine, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, Washington D.C and Europe. Philip went through three rounds of auditions and an application process which started in the Fall of 2019 when Philip was selected as a member of the Massachusetts Eastern District Jazz Ensemble. He was then selected to participate in the Massachusetts All- State Jazz Ensemble in March of 2020, paving the

way for his eligibility to apply for All Eastern. Philip will represent Milton High School as the vibraphonist in the All Eastern Jazz Ensemble. He is one of 18 students who were selected to be in the Jazz Ensemble and will be participating in a "Virtual Weekend" experience March 4-6, 2021 that will include keynote speakers, master classes with professional musicians, rehearsals with a world class conductor, as well as opportunities to learn and network with colleges and universities of various types and participate in mock auditions. This experience will culminate in a virtual concert which will be premiered on April 23rd at 8:30pm.

 - Superintendent Jette told the community that he appreciated the community calling in and speaking to the School Committee and Administration

5. Chair's Report - Chair Varela

Chair Varela made a note that she and Dr. Donahue have been in discussion regarding the Anti Racism Policies. Somaly Prak Martin will be presenting Anti Racism Policy and the MPS Hiring Policies at the February 24, 2021 School Committee Meeting.

Open Meeting Law Violation Thursday, January 21 from the Milton Times, Patricia Desmond

- A complaint was filed with the Attorney General's Office
 - Stating that the School Committee failed to post an item saying they planned to vote on appointing a Superintendent.
 - Complaint stated that the School Committee should post an agenda with the specific item. Appointment of Superintendent at a future meeting and then vote.

- Chari Varela reached out to General Council: Attorney Joseph Emerson regarding the next steps. Joseph Emerson stated that School Committee needs to:
 - Speak about the complaint within of 14 business days of receipt of the violation
 - Joseph Emerson would join an open School Committee meeting to openly advise the School Committee about the complaint. He would also be available to any questions School Committee may have
- Attorney Joseph Emerson joined the School Committee Meeting commented:
 - Complaint was received January 21st about the actions that were taken at the meeting on January 20, 2021
 - o 14 business days to meet and review
 - o distribute the complaint to other members to review
 - o purpose of this meeting is to go over the options and review the complaint
 - Have the authority to delegate to respond to the complaint
 - Have the complaint, review and actions to be taken
 - remedial actions can include the request to be made to post the action again and vote again in open session
 - o Or can decide that there has been no violation of the open meeting law
 - Once you make a decision is made, Ms. Desmond needs to be notified and a copy is then sent to the Attorney General's Office
 - If Ms. Desmond is not satisfied with the decision of the School Committee, she has the right to ask the Attorney General's Office to review further
 - Looking at the basis of complaint itself, it is the posting was not appropriate for the action that was taken
 - Review of the determinations of the Attorney General's Office, Open
 Government. Have had similar cases and were reviewed, and the finding was no violation of the open meeting law
 - Suggested the School Committee have an open discussion and reply
 - Chair Varela asked how the School Committee members feel or if there were any questions
 - Ms. Rosmarin stated that the vote naturally flowed from the conversations on January 20th and nobody really expected the vote to happen that night. It was a somewhat rare moment where all agreed and a decision was made through the conversation.
 - Ms. Eberhardt also agreed with Ms. Rosmarin. Naturally evolving conversations should not be considered a violation. Having a conversation in an open meeting as is required by law. Ms. Eberhardt stated that she did not feel the School Committee violated the open meeting law.
 - Dr. Craghead agreed with Ms. Eberhardt and Ms. Rosmarin. The agenda item said the School Committee would be discussing the process of the Superintendent and repeating the process to the community. Did not expect the flow of the conversation to go into a vote but it happened unanimously.

- Chair Varela stated that Ms. Eberhardt went through the process with the advice of Glenn Koocher. (MASC) Glenn Koocher was able to join a School Committee meeting for a presentation and clearly stated if the School Committee had a candidate here and now, that School committee had the authority to make a vote. Chair Varela mentioned when Dr. Donahue made the motion from the flow of the conversation and it was posted on the agenda, and didn't think it was in violation.
- Dr. Donahue agreed with the members who have spoken, Glenn Koocher stated that the School Committee had the authority to make a decision and to vote during his presentation.
- Ms. White stated she agreed with all the members of the School Committee.
 Have been thinking about the right person for the Superintendent since
 August. Ms. White felt confident when Mr. Jette took the interim position.
 The discussion flowed into the right decision for the best leader for our district.

Chair Varela made a motion to authorize Attorney Joseph Emerson to respond to Ms. Desmond at the Milton Times that the School Committee is in disagreement with the complaint that the School Committee violated the open meeting law.

8. <u>Citizen Speak Reponses - Dr. Donahue</u>

- Over the past several weeks and months there has been several criticisms toward School Committee members
- Wanted to respond to the general criticism
 - witness the ramifications of the frustration of the community
 - o understand the difficulties from the families
 - the deeper we get into the academic year, understand the daily contact is key for all students which is available in the current model
 - o comfortable with the decision that was made
 - o increasing time now in February is due to the safety, time and money
 - planning taking place to moving forward due to the members of the School Committee members and Administration
 - trying to move as fast as possible and understand the community questions our decisions
 - Best use of resources were available to help make decisions for the School District
 - Appointing a Superintendent was a community engagement process including survey, open sessions and involved for MASC
 - Returning to school full person model is not a decision that School Committee making at this time, will require a most robust process
 - Need more support and direct guidance from the state and local level
 - Space is an ongoing issue, at this time we cannot accommodate all of our students safety
 - Thanked the community for their support
