Phase I: Learn & Prepare (Summer 2020 → Spring 2021)

- ★ Establish a curriculum council, selection timeline, and final decision-making process
- ★Develop a common understanding of MA Massachusetts Mathematics Curriculum Framework (along with research articles, such as Five Reasons Instructional Materials Matter for Equity and The Mo(ve)ment to Prioritize Antiracist Mathematics) among curriculum council members
- ★Establish our local lens
 - Identify local parameters for our decision (budget, grade levels, content area, etc.)
 - Develop our vision and goals for instruction and assessment
 - Set priorities to guide the decision-making process
- ★ Plan for stakeholder engagement throughout the entire process
- ★ Understand the market landscape: What are the options?

Phase II: Investigate & Select (Fall 2021 → Spring 2022)

- ★ Narrow the choices: Use the parameters to identify a subset of programs that can be deeply investigated
- ★Investigate each program using our vision and priorities to rate them
 - MPS K-5 Math Curriculum Review Program Investigation Details
- ★ Gather data from other districts, stakeholders, and publishers
- ★ Make a final decision by mid-April
 - Synthesize and analyze evidence of meeting priorities
 - Communicate the decision and plan for implementation to all stakeholders

Phase III: Launch (Spring 2022 → Fall 2022)

- ★ Procure materials and plan for distribution
- ★ Set implementation goals for assessments, pacing, and monitoring
- ★ Set expectations for use and collaborative planning
- ★ Determine an plan for observation and coaching
- ★ Train teachers, support staff, and administrators

Phase IV: Implement & Monitor (Fall 2022 \rightarrow)

★ Provide ongoing training focuses on the curriculum design, instructional practices, and planning at the unit and lesson level

- ★ Monitor student engagement, feedback, and performance on assessments
- ★ Make adjustments as needed based on quantitative and qualitative data

Dr. Carroll

- Thanked Brian Selig for the presentation and for leading this rigorous process in seeking out our elementary math curriculum
- Asked Mr. Selig if he could clarify and explain where the rubrics came from, did they come from your team or another source?

Brian Selig replied

- The language is not our own, it derived from National Council of Teachers of Mathematics (NCTM)
- Transcendent publication in Math Education
- Teacher Centered instruction transitioned to Student Centered
- Much of the work to date has been rooted in that text

Dr. Carroll

• Had a question about the mention of other districts implementing some of these different curriculums, the initial Professional Development and support for preparing to implement to launch. Is that included in the purchase price of the curriculum?

Brian Selig replied

- Yes, it is included in the cost, it is impossible to purchase a curriculum without some level the Professional Development
- Can customize to individual district needs

Dr. Carroll

- Mentioned the intention of selecting a curriculum that we invest in for that 5+ years
- When did we adopt our current elementary math curriculum
- Want the community to understand that it is a necessary transition that we reach beyond the lifespan of the curriculum we have

Brian Selig replied:

- Don't have the exact number of years but want to say it could be 20+years
- Everyday math has been all that has been mentioned in the curriculum over the years

Assistant Superintendent Sheehan

• Although we have had Everyday Math for many years, we have updated through Math 4, maybe 8-10 years ago

Superintendent Jette

• Replied it was 9 years ago

Brian Selig

- Long period of time lapse
- Significant amount of change has come to math education at the elementary level
- What we have now is outdated

Dr. Carroll

- We talk about striving for excellence for our students
- This is a clear example of what needs to be put into action
- As an early elementary parent, thankful for you doing this work
- The new curriculum will be translated into French as well

Ms. Rosmarin

- Thanked Brian Selig and team
- Looking forward to seeing this roll out
- What are we thinking in terms of the implementation roll out, will this be all grades K-5 or a couple of grades at a time

Brian Selig

- Think there is urgency
- Intent to have the new curriculum across K-5 in the fall
- Need to benefit from a curriculum, can be a rocky transition for both teachers and students
- The curriculum will be unfamiliar
- Notable better, it is worth it
- Professional Development is critical to the success
- Both roll outs have merit, push forward for all elementary grades for the fall

Ms. Rosmarin

- Agreed since the current curriculum is outdated
- Want to do the best by our students

Ms. Ross Denny

- Thanked Brian Selig for taking the time to implement such a rigorous plan
- Have had the benefit of being a part of the Curriculum Instruction Advisory Group
 - the good thing is we do have precedent of other schools that have done well in their first year of implementation

- It might be bumpy, we do have a track record of being successful
- Now we have planning time district wide, teachers can learn from one another
- Will be much more prepared than they would have been years ago
- Read the Ed Report, current math curriculum did not meet in terms of being rigorous
- It is very important we use this opportunity to offer this curriculum to our students as soon as possible

Chair Eberhardt

- Years ago Everyday Math out was rolled out backwards, starting with the 5th grade
- Looking forward to the new curriculum
- How are you aligning with the Middle School curriculum
- What are the outcomes when they get to Middle and High School, would like to see some connection

Brian Selig

- There have been a number of publishers that have tried to appeal to desire for consistency and offer programs K-12
- The flaw in that is, not often of the same equal quality at the levels
- Should get the best we can for the age level we have for K-5
- Feel confident with our middle school curriculum and transition

- Received a question about how does mask optional work at lunch
- What plans are in place to make sure students feel safe

Superintendent Jette

- It is tight in some of our cafeteria's, do our best to socially distance, but no longer guidance at this time
- Nothing different during lunch, except if the students decides to wear their mask
- No silent lunches
- Students with any concern should reach out to their building nurse

- Pre Registration for Kindergarten just completed, 326 have registered
- 142 preschool students registered
- Numbers are growing in schools
- March 17- Parent/Teacher conferences will be in person
 - will provide other opportunities for families to reach out to teachers to meet virtually at another time
- 10th graders ELA MCAS on March 22nd and March 23rd

Ms. Rosmarin

• If parents prefers a remote parent/teacher conferences, just wanted to confirm that is an option

Superintendent Jette replied

- Yes, parents/guardians should reach out the week before or after to schedule time to meet remotely or could call the teacher as well
- Should set up with their individual teachers
- Mask optional as well for the conferences

Ms. Ross Denny

- Know the Leadership Team spoke about the Open House in person as well
- Appreciate the options
- For working parents it can be challenging to leave work in the middle of the day for the meeting, it would be good to have the default option for zoom, last conference set up was helpful

SCHOOL YEAR/SCHOOL CALENDAR

REDLINE for 3-1-22

The school calendar for the ensuing year will be prepared by the Superintendent after sharing and discussion with the Milton Educators Teachers' Association and then submitted to the School Committee for approval by May 1st of each year.

The number of days or instructional hours scheduled for the school year will be determined in accordance with the following standards set by the Massachusetts Board of Education:

- 1. Elementary school will operate for a minimum of 180 days. Each elementary and middle school student will be scheduled to receive a minimum of 900 hours per school year of structured learning time, as defined in 603 CMR 27.02. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, receiving school services, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.
- 2. Secondary schools will operate for a minimum of 180 days. Every secondary school student will be scheduled to receive a minimum of 990 hours per school year of structured learning time, as defined in 603 CMR 27.02. Time which a student spends at school breakfast and lunch, passing between classes, in homeroom, at recess, in non-directed study periods, receiving school services, and participating in optional school programs shall not count toward meeting the minimum structured learning time requirement for that student.

State and federal laws require schools to make reasonable accommodation to the religious needs of students and employees in observance of holy days. Mass. General Laws Chapter 151B, section 4 (1A) addresses this issue with respect to employees. With respect to students, Mass. General Laws Chapter 151C, section 2B reads in relevant part as follows:

1. Any student in an educational or vocational training institution...who is unable, because of his religious beliefs, to attend classes or to participate in any examination, study or work requirement on a particular day shall be excused from any such examination or

study or work requirement, and shall be provided with an opportunity to make up such examination, study or work requirement which he may have missed because of such absence on any particular day; provided, however, that such makeup examination or work shall not create an unreasonable burden upon such school. No fees of any kind shall be charged by the institution for making available to the said student such opportunity. No adverse or prejudicial effects shall result to any student because of his availing himself of the provisions of this section.

In the case of religious holidays that are not recognized with a holiday (day off) in Milton Public Schools:

- 1. Whenever possible, Milton Public Schools will avoid scheduling district- or school-wide meetings (eg. Kindergarten Information Night) in conflict with a religious holiday, even if it is not a school holiday.
- 2. <u>Parents/guardians are asked to notify teachers, in advance, when a student is planning to be absent in order to observe a religious holiday. In addition to absence from school, any absence from extracurricular activities, due to the observance of a religious holiday, will be considered as an excused absence.</u>
- 3. Whenever possible, reasonable accommodations to the religious needs of students and employees in observance of holy days shall be made (eg. in the case of someone who is fasting for Ramadan).

For the information of staff, students, parents <u>and guardians</u>, the calendar will set forth the days schools will be in session; holidays and vacation periods; professional development <u>days</u>; and parent conferences.
