#### **Glover Elementary School Procedures**

#### **Message from the Principal:**

#### **The Glover School Shares the Milton Public Schools Vision:**

We, the Milton Public Schools, envision a district with excellent instruction in every classroom, where learning experiences are aligned with students' individual strengths and needs, and where attention to academic and social emotional growth are balanced so that every child achieves at high levels and develops a strong sense of

self. We see a district of intellectual discourse and professional learning at all levels- students, faculty, and administration- in which there are structures and processes for continual reflection, innovation, and data driven decision-making. We know that such a district is achievable if: we facilitate instruction that instills a passion for learning, curiosity, and critical thinking skills; we are committed to cultural competency; we foster a positive approach to the behavioral health of children; and we build strong partnerships with families and the community.

#### **Glover School Hours:**

Glover Elementary School hours are 8:50-3:19. Students may enter the building starting at 8:35. All students are dismissed to either the bus, after school, pick up line, or as walkers/bikers at 3:19.

#### **Early Arrival/Extended Day Programs:**

All days that Milton Public Schools are in session, Milton Community Schools offers both before and after school programs housed at all four elementary schools. A wide variety of programs are offered to the students and costs vary depending upon level of participation. Discounts are available for full-time program use and for additional siblings in the program. Financial aid is available to qualified applicants. School vacation and early release day programs are offered for an additional fee. #### **Glover School Arrival and Dismissal Procedures:**

#### **Arrival Procedures:**

Students should arrive between 8:35am and 8:45am. As there is no supervision prior to 8:35am, families requiring an earlier drop off should contact Martha Sandoval at <a href="mailto:msandoval@miltonps.org">msandoval@miltonps.org</a> to enroll their child/ren in the Before School Program. Upon arrival, students will travel to their classrooms where they will wait outside of their classrooms at their lockers until 8:50. Kindergarten students will go directly to the cafeteria where they will be greeted by staff. Staff will monitor hallways, doors, and entry/exit from building. To ensure we are efficiently using time on learning and providing the safest environment for our students, we do NOT allow parents to accompany students to their classrooms during morning drop off.

#### **Dismissal Procedures:**

Dismissal takes place at 3:19 pm. Students who take the bus will convene in the cafeteria and be escorted to their buses. Kindergarten students will exit through the main doors of the school a few minutes earlier than Grades 1-5. Grades 2-3 will exit through Exit "B" located immediately in front of the small playground. Grades 1, 4, and 5 will exit through the main doors of the school.

#### Car Drop Off/Pick Up:

- Cars must only take a right turn into the parking lot via Entrance "1" (closest to Brook Road) and proceed through the parking lot to the curb at the end of the footpath. Please do not take a left into the car line from Brook Road.
- Vehicles should pull as far forward as possible, and most importantly, remain in the car at all times.
- No driver, passenger or student should EVER exit the driver's side doors. Do not get out of your vehicle to get your child out. We have staff to assist with this. Please strategically seat your children so that they can exit the passenger side only.
- The Turner's Pond parking lot is not accessible during drop off and pick up as it is not monitored by staff.
- Do not enter the parking lot via Entrance "2" (bus entrance).

- If you are using Whitelawn Avenue to park and walk up to the school, please enter on the far end (towards School Street) only.
- Do not let your child out of your vehicle on Canton Avenue at any time.

#### Walkers/Bikers:

- Second, third, and fourth grade walkers exit out the side doors (closest to the Turner's Pond gate) at 3:19. Kindergarten, first grade, and fifth grade walkers exit out the main doors of Glover. We ask parents/guardians to meet their walkers at the designated doors. If you are picking up at multiple doors, please make a plan with your children and their teachers as to where you will be.
- Students who are walkers will not be dismissed from their teacher's care until a designated and approved adult has checked in with the teacher and dismissed them.
- Only fourth and fifth grade students (and siblings of these students) who have a walk/bike to school permission slip signed in the front office may be dismissed without an adult present.
- Students who have not provided written or oral notification of a change in dismissal will not be released to anyone other than designated adult.

#### **Independent Walkers/Bikers:**

Walkers and bikers must use crosswalks with the assistance of the crossing guard to cross at the intersection of Brook Road and Central Avenue. Fourth and fifth grade students can receive written permission to walk/ bike independently to and from school. Permission slips, which include specific bike safety rules, can be found in the main office. Permission slips **must** be signed and returned in order for students to walk/bike independently to and from school. If younger siblings are going to walk independently with older siblings, it must be denoted on the permission slip. If your child is walking independently with a neighbor or friend, it must also be submitted in writing by both parties.

#### **Buses:**

Buses will use **Entrance**/ **Exit "2"** (closest to and across the street from Whitelawn) and drop off/pick up students at the side parking area. To ensure the safety of ALL students, teachers will escort students to and from buses. #### Early Dismissal:

- Request to change dismissal plans should be submitted in writing to your child's teacher via email **and** folder.
- If dismissal plans change after <u>12:00</u> during the school day, parents/guardians <u>must</u> call the main office. Teachers may not be able to check email and all dismissal changes should be made through the main office.
- Parents/guardians must come to the main office to sign their child out of school.
- Without notification, students will not be dismissed between 3:00-3:19 unless there is an emergency.
- If you change dismissal plans on a day when your child normally attends the after school program, you must notify ASE.

#### **Late Student Pick-Up Policy:**

Similar to the concerns for student safety during the early morning hours is the concern for student safety after normal school hours. Therefore, if your child rides the bus, we ask parents/guardians to please make sure an adult is present to greet their child/children at the designated bus stops. If you pick-up your child from school, we ask that you arrive no later than **3:19pm.** We recognize that emergencies arise and ask that you please call

the main office in the event you will be later than **3:19pm** so we can arrange for supervision. However, parents/guardians, who pick their child/children up late more than two times, will be required to enroll their child/children in the Afterschool Program. Parents/Guardians who want a student(s) to be released to an alternate adult should notify the teacher and office staff (via email or note). Office staff emails are listed on the bottom of this memo. All adults must be prepared to present a state-issued ID to office staff.

#### **Security Procedures at Glover:**

We value a strong community presence here at Glover but balance this with the importance of ensuring student safety at all times by closely monitoring access, entry, and movement of all adults around the building. In order to ensure student and staff safety, please adhere to the following procedures:

- All adults/visitors must use the main entrance of Glover School. Entry through any other door during the school day (8:50-3:19) is prohibited. Only students and employees may enter the building through entrances other than the main entrance.
- During the school day, guests must ring the doorbell to gain access to the vestibule and once again to gain access to the school. Office staff must be able to clearly see your face on the camera before you gain entry.
- All adults who plan to stay in the building should give the office staff a valid state-issued ID so that a Visitor's Badge can be printed. All adults without a badge will be asked to immediately return to the office to receive one. Badges must be visible at all times.
- All adults must sign in on the Visitor's sheet located in the main office. Upon leaving, guests should sign out and return their badge to office staff. Guests should always exit through the main entrance unless escorted by an employee to a different exit in the building.
- All adults who stay in the building need a CORI form on file. CORI forms need to be filled out through the office.

#### **School Lunch:**

Your child has the option to buy a delicious and healthy lunch every day. A full lunch is \$2.00. Milk and water are an additional \$0.50. Discounted and free lunch programs are available to qualifying families through the Milton Public Schools. Forms are sent home with each child at the beginning of the school year or you may contact the Food Service Director for further information. In an attempt to simplify the payment process for your child's breakfast/lunch, we have installed 2 mailboxes within the school; one mailbox is located in the main office and the other is on the wall in the cafeteria. Checks should be made payable to the Milton Food Service Program.

Please remember that parents are encouraged to set up an online account at <a href="www.myschoolbucks.com">www.myschoolbucks.com</a>. Families can manage their child's account on this site and sign up for low balance email alerts to manage debt.

#### **School Breakfast**

We serve a hot breakfast every day starting at 8:15. Students may be dropped off at the side door (by the cafeteria) starting at 8:15am on a walk-in basis (no registration required) and can purchase breakfast. As with lunch, discounted and free breakfast programs are available to qualifying families.

#### MEAL CHARGE POLICY

The Milton Public School System participates in the National School Lunch Program sponsored by the United States Department of Agriculture (USDA) which permits the school system to offer free and reduced priced meals to students who qualify. Families who wish to apply for free or reduced meals must complete an application each year. The family of any Milton Public school student may submit an application at any time during the school year. Applications are available in each school's main office, at the food service office and online at www.miltonps.org

#### STUDENT ACCOUNTS

Any student whose school meal account has a zero or negative balance will be allowed to charge a reimbursable meal and/or milk. A "reimbursable meal" is defined as a meal consisting of at least three (3) of the five (5) offered meal components (grain, meat or meat alternative, fruit, vegetable and milk) and must include a fruit and/or vegetable component. This will result in a negative balance on the student's account until funds are added to the student's account.

Families will be notified weekly by the food service program if their account is negative. The food service program will work together with the school administration in a joint effort to contact students/parents to assist with collections.

Student with a negative account balance will not be allowed to purchase a la carte items until the student's account is in good standing. "Good standing" for the purchase of a la carte items is defined as an account with a positive balance.

#### **Payment Options**

The Milton School Food Service Program offers an online payment option as well as a payment by check. Our online website is www.myschoolbucks.com

We encourage our families to pre-pay for meals at the paid or reduced price rate to help to ensure children have consistent access to meals without accruing unpaid meal charges. This pre-payment system includes a feature to allow for parental restrictions limiting a child's spending at the point of service. For example, the system could allow families to place specific limits on à la carte purchases. Families can contact the food service office for further information.. We also accept checks at all six of our schools. We have locked mail boxes in the cafeteria and main office of each school. Checks should be made out to the Milton School Food Service Program.

#### Online Payment

We allow families to add money to their child's account from a computer or mobile device which makes payment more convenient for families.

Often, even families who do not opt to pay using the online system can access the system to check their child's account balance. Many families may not realize how much their child is spending in the cafeteria each day, especially if the child is purchasing à la carte items in addition to their reimbursable breakfast and lunch. We encourage families to regularly check their account balance and track their child's spending can help prevent households from accruing unpaid meal charges.

#### Automatic Payment

We also offer online payment platforms that include an optional feature families may use to automatically add money to their account when they reach a set dollar amount. Families using these systems may also set up a "low balance warning" to ensure they are notified promptly when a payment is needed.

The Milton Public Schools will work together with all of the fee based programs and activities. At the end of each school year students with an outstanding food bill above (\$20.00) will not be allowed to register for any fee based program until the food balance has been paid off.
